**Volunteer Advocacy**

**Why did you decide to become an advocate?** I decided to become an advocate because I wanted to get involved in helping children in the foster care system but I didn't think foster parenting was for me. One morning in 2006 I was watching a

morning talk show and a person was talking about CASA and that sparked an interest. I believed CASA sounded like something I could do. I went on the website that was given. I was connected to IL CASA, then the Peoria office, and the rest is history.

**Do you have any advice for other Volunteers?** Utilize the resources you are given through in-services and the support you are given from Pam and Melkecia. Also keep detailed notes as you go along to help you write better court reports.

**What has been one of your most memorable moments as a CASA Volunteer?** My most memorable moment was being in the courtroom when the biological mother, of the children on my first case, lost her parental rights.

**What keeps you motivated on your case?** Knowing that the decisions that are made effect the child's life motivates me to want to gather good and accurate information that is pertinent in helping the judge decide the best fate of the child's future.

**What are your challenges as a CASA?** Writing a good, detailed, accurate court report that is not full of my own opinions.

**Keeping the Fire by Melkecia Welch**

**Protecting Passion**

## 5 Secrets for Great Report Writing

1. Begin work on your court report with plenty of time before court. This will allow time for you to clarify any questionable information, submit the report to your supervisor for editing and ultimately get the report to the court three weeks before the hearing.
2. Make the report child-centered.
3. Be accurate. This means reporting objectively and factually—presenting exact information free from errors, misstatements and personal judgments.
4. Use the fewest number of words possible to describe an action or occurrence. Avoid using unnecessary words for technical jargon. Don't give the judge information he or she does not need to know.
5. Make sure that your report is in a chronological format and includes your CASA child's wishes before submission to your supervisor.

### CASA Program Description

A CASA volunteer is a highly trained advocate that is; an *information gatherer*, obtaining all relevant facts about the child and the case; an *advocate* to ensure that those facts are brought before the court through reports presented to the court with copies to case parties, and a *facilitator*, to ensure that all fulfill their legal obligations to the child in a timely manner. A CASA volunteer is assigned to one case at a time and serves on that case until it closes.

The system, including judges, struggles every day to protect these children because of lack of information. CASA of Peoria County can help to ease the burden by providing valuable new information. In fact, preliminary findings suggest that children who have been assigned CASA volunteers tend to spend less time in court. We ask you to join our community to provide resources to grow CASA of Peoria County to meet the need of the growing new and pending child abuse and neglect population in Peoria County.

CASA of Peoria County will greatly enhance the services provided to abused and neglected children in protective custody. Unfortunately, due to resource constraints, a Guardian Ad Litem or caseworker will be responsible for hundreds or dozens of cases respectively. The CASA advocate provides crucial background that neither the caseworker nor the Guardian Ad Litem has the time or resources to provide.

available that will help feed the passion inside of you. For example, I was reading a book titled *Listen to Your Life* by author and life coach Valorie Burton. As I was reading, I began to smile and get excited knowing the author and I share a similar passion to encourage others to find their path in life. My confidence is growing, as I continue to read this book, because I have an example of a like passion at work.

### **Spreading Your Passion**

Fire that is fed begins to spread and consume anything it touches. Now that you are committed to keeping your passion before you and you are feeding it with new thoughts or ways that keep it growing, it is time that you spread

your passion. Share your passion for CASA with your surroundings. Talk about the difference CASA makes in Peoria County. Talk about the difference you make in a CASA family's life or how being a CASA has made a difference in your life and watch how the fire inside you continuously burn.

What better time than now do the needs of our children and families need a passionate advocate helping to see that their needs are being met. So let's keep the fire burning by continuing to protect, feed, and spread our passion for CASA volunteering.
