What is CASA?

CASA stands for **Court Appointed Special Advocates**. CASA ensures that abused and neglected children have courtroom advocacy and access to services and resources. A non-profit organization, CASA of the Tenth Judicial Circuit recruits, trains, and supervises volunteers who are the voice for children in the courtroom; keeping the children's needs at the forefront of pertinent decisions regarding their future.

Who benefits from the money raised at this event?

Abused and neglected children in Peoria, Tazewell, Marshall, Putnam and Stark Counties ultimately benefit from the funds raised at Sip, Savor, Smoke. Proceeds help CASA of the Tenth Judicial Circuit support volunteer advocates, grow the program and expand advocacy for local children. By using trained, community volunteers, CASA provides an innovative, cost-effective solution to a crisis in the juvenile justice and foster care system. The approximate cost (excluding in-kind contributions) to advocate for a child for a year is \$1,200. You have the opportunity to make a difference in a child's life today and help us ensure placement in a safe, permanent home with an opportunity to thrive! Important Facts:

- In 2018 CASA of Peoria County expanded to the entire Tenth Judicial Circuit, adding 4 more counties to our service area!
- Last Fiscal Year, CASA of Peoria County (now CASA of the Tenth Judicial Circuit) served 328 children.
- There currently are over 1,500 pending abuse and neglect cases in the Tenth Judicial Circuit. CASA is recruiting volunteers to advocate for these children but needs funding to train and support their efforts.
- Illinois is one of only seven states in the country that does not fund CASA.
- The average monthly cost for a child placed outside the family home is \$5,698. CASA involvement reduces the time a child spends in foster care by an average of eight months—saving taxpayers an average of \$45,584 per child.
